Veterans Justice Outreach (VJO)

Liaison

Justice Outreach staff serve as a link between law enforcement, courts, and detention centers and the VA Medical Center. They provide training and education related to Veteran-specific needs and available services. VJO staff will assist eligible Veterans with access to services.

VA Eligibility Determination

VJO staff will facilitate contact with VA eligibility staff in order to provide Veterans with information about eligibility for VA services.

Homeless Outreach Program

Healthcare for the Homeless Clinic

- 8:00—12:00 Monday, Tuesday, Friday
VA staff are available to provide services to homeless Veterans.

Grant & Per Diem Transitional Shelter

- NM Veterans Integration Center
- Albuquerque Opportunity Center

Case Management support and referral to housing services.

Vocational Rehabilitation Services to assist Veterans with access to permanent employment.

Outpatient Behavioral Health

Outpatient treatment services include the following specialty clinics in addition to treatment focused on anger, depression, anxiety, bereavement, and family concerns.

Substance Use Disorders Clinic

Group and individual intervention for Veterans in early recovery.

- “Mini Intensive Treatment Program (MITP)” involves 11 weeks of treatment up to six hours per day.
- Individual psychiatric, nursing, and social work appointments throughout treatment episode.
- Follow-up care & relapse prevention.

Treatment for Post Traumatic Stress

- Military Trauma Treatment Clinic offers evidence-based individual and group treatment for male Veterans with military related trauma.
- Women’s Stress Disorders Clinic offers evidence-based individual and group treatment for female Veterans with history of trauma.
- Outpatient Mental Health offers evidence-based individual and group treatment for Veterans with non-military related trauma.

- Average Length of Stay = 90 days
- Voluntary Participation

Homeless Domiciliary (DRRTP)

40-bed unit provides treatment for homeless Veterans with substance misuse and mental health conditions while focusing on psychosocial needs such as housing, income, and employment.

PTSD & Substance Misuse (STARR)

24-bed unit provides treatment for Veterans with co-occurring post-traumatic stress and substance misuse.

Psychosocial Rehabilitation (PRRTP)

16-bed unit provides step-down care for Veterans exiting DRRTP or SARRTP with a primary focus on community reintegration.

Gallup PRRTP

10-bed unit provides treatment for Veterans with substance misuse, with a focus on Native American Veterans.

Work Therapy / Transitional Residence

5 beds on NMVAHCS campus, 4 beds in a house in the community, focused on employment and community reintegration.
